Copyright guidelines must be followed in downloading or copying images and files.

Customers must not modify or gain access to restricted files or data belonging to others

Customers must not access sites which are inappropriate or offensive in a public place given the wide range of ages of library patrons

Staff will monitor compliance with “Conditions of Use” using a variety of methods including personal observation and reviewing of record logs.

Customers who breach these ‘Conditions of Use’ may face sanctions including having access withdrawn.

Oran Park Library Media Pod Conditions of Use

Users must agree to the following Terms & Conditions:

1. Appropriate student identification or proof of attendance must be shown to staff before access is given to the study room.
2. Maximum of 6 people in Media Pod.
3. Media Pod is not available for non-profit or commercial use.
4. Maximum booking time is 2 hours per person per day
5. Failure to turn up within 15 minute of original booking time will forfeit the use of the room.
6. Media Pod is to be kept clean and tidy.
7. Bookings will be cancelled for inappropriate behaviour.
8. Customers must not access sites which are inappropriate or offensive in a public place given the wide range of ages of library patrons
9. Staff will monitor compliance with “Conditions of Use’ using a variety of methods including personal observation and reviewing of record logs.
